## HARNESS RULING #32

**MEETING - ALBERTA DOWNS, LACOMBE, ALBERTA, CANADA** August 15, 2011

On Tuesday, August 9, 2011, Maxxam Laboratories reported that the urine sample of the horse "RED STAR GOVERNOR", first place finisher in the 11th race on Sunday, July 31, 2011, tested **POSITIVE** for the forbidden drug **EPHEDRINE, PHENYLPROPANOLAMINE, PYRILAMINE AND O-DESMETHYL PYRILAMINE**.

In accordance with HORSE RACING ALBERTA Licensing Rules 63, 64 and 65, **OWNER/TRAINER/DRIVER, AUTHORIZED AGENT, DAVID FREDOLF JUNGQUIST, PERM. ADD.: SURREY, BRITISH COLUMBIA, CANADA, D.O.B. OCTOBER 1, 1949**, is hereby **SUSPENDED AND DENIED THE PRIVILEGES OF THE GROUNDS (INCLUDING GRANDSTAND) OF ALL ALBERTA RACE TRACKS FOR A PERIOD OF SIX MONTHS, AUGUST 16, 2011 TO FEBRUARY 15, 2012 (INCLUSIVE) AND FINED THE SUM OF FOUR THOUSAND DOLLARS (\$4,000.00)**.

All horses owned by Mr. Jungquist shall be denied entry for a like period of time unless a sale takes place under HORSE RACING ALBERTA Rule 65(2). All horses trained by Mr. Jungquist shall be denied entry pending their transfer satisfactory to the Board of Judges.

The horse "RED STAR GOVERNOR" is hereby **DISQUALIFIED** and declared **UNPLACED** and the purse money shall be re-distributed as follows: 1st: "BEST OUT WEST", 2nd: "CLEAR BLUE", 3rd: "HAVANNA RULES", 4th: "READY TO GO", 5th: "ROSSRIDGE EXPRESS". The Horsemen's Bookkeeper is hereby ordered to make the necessary purse and Alberta Sired Bonus adjustments.

In accordance with HORSE RACING ALBERTA Rule 40(1)(2), 167, 168, 169(1)(2), 187(a), 188(1)(xdi) and 195(2)(a)(b). Fine to be paid before re-instatement.

This ruling shall in no way affect the Pari-Mutuel wagering.
